Award Guidelines

The ADA Foundation Dentsply Sirona Research Award for Dual Degree (D.D.S./Ph.D. or D.M.D./Ph.D.) Candidates

Purpose: The purpose of the ADA Foundation Dentsply Sirona Research Award for Dual Degree Candidates is to promote and recognize excellence in oral health research by providing financial assistance to dual degree candidates who are interested in pursuing a career in research that advances the oral health of the public.

Focus: The oral health research must have a basic biomedical, clinical, or translational focus.

Award Description: Each award winner will be required to attend the American Association for Dental Research (AADR) Student Competition for Advancing Dental Research and its Application (SCADA) competition. The Award will provide funds up to \$10,000 to fund expenses to attend the AADR SCADA competition and, in addition, may be used to defray the cost of one or more of the following:

- A research project approved by the ADA Foundation; and/or
- Attending one or more scientific conferences in order to further his/her knowledge or skills; and/or presenting his/her findings at such scientific conference.

Eligibility: Dual degree candidates (defined below) who are U.S. citizens in good academic standing and are currently enrolled in an eligible program (defined below) may apply.

A dual degree candidate” is defined as an individual pursuing both a D.M.D./D.D.S. degree and a Ph.D. either simultaneously, or in sequence within a period of five years from the completion of the first degree and the start of the second.

An “eligible program” means a program at a U.S. public, nonprofit or privately owned college or university accredited by the ADA Commission on Dental Accreditation.

Application Requirements: Applicants must submit the following required materials via the online application portal at www.grantinterface.com/adafoundation/common/logon.aspx

- Curriculum vitae;
- Research abstract;
- Two letters of support, one of which must be from the applicant's research mentor or program director; and
- Any other supporting documentation the applicant deems relevant.

Report Submission Requirements: The Award recipient will be required to submit the following within one year of receipt of the Award funds:

- A report detailing the activities and outcomes funded by the Award; and
- Proof of attendance at the AADR SCADA Competition and any other scientific conference whose attendance is sponsored by the Award.

Acknowledgement by the Recipient: If the research supported by the Award leads to a research paper intended for publication or presentation, it is expected that the manuscript be submitted to the Journal of the American Dental Association (JADA) for consideration. If such a paper is accepted for publication, or a presentation is made based on that paper, the Award recipient must acknowledge the research is partially funded by the ADA Foundation Dentsply Sirona Award for Dual Degree Candidates.

Application Deadline: All applications must be received by 11:59 p.m. CT on Friday, November 3, 2017. Incomplete application materials will not be considered.
